#### Evaluation Process

### Step 1- Checked for completeness of Tender Offer

Tender offers will be screened to identify schedules and requested documents that are incomplete or have not been submitted.

- Test for responsiveness
  - 1. Tender offers will be tested for compliance with all the requirements of the as-amended Standard Conditions of Tender including the following:
  - a) Eligibility (C.2.1.1)
  - b) Pricing the tender offer (C.2.10)
  - c) Alterations to documents (C.2.11)
  - d) Alternative tenders offer (C2.12)
  - e) Submitting a tender offer (C.2.13)
  - f) Grounds for rejection and disqualification (C.3.7)
  - g) Test for responsiveness (C3.8)
  - 2. Tender offers will be declared non-responsive should they fail to comply with any one of the requirements of 1) above.

- 3. Non-responsive Tender Offers will not be further evaluated.
- Local Production and Content Pages 53-67 of the document.

A Compliance Assessment will be undertaken on the shortlisted tenderers.

Only tenderers who have completed fully and declared the minimum threshold percentage for local production and content for all sectors identified (designated sectors) as stated in the National Treasury instruction note will be deemed responsive.

Non-responsive Tender Offers will not be further evaluated.

Capability Requirements (Functionality)

A Compliance Assessment will be undertaken on the shortlisted tenderers. The compliance assessment will be based on the information submitted in the Returnable Schedules and will assess the likely risk of the Tenderer not being able to successfully perform the work under this contract and meet all his/her contractual obligations.

If the assessment indicates that, there is an unacceptably high risk of the Works not being successfully completed, the bid will be rejected. The overall assessment will consider all of the following:

#### Risk Analysis

Notwithstanding compliance with regard to CIDB registration or any other requirements of the tender, the employer will perform a risk analysis in respect of the following:

- (a) reasonableness of the financial offer
- (b) reasonableness of unit rates and prices
- (c) reasonableness of commitments

The conclusions drawn from this risk analysis will be used by the Employer in determining the acceptability of the tender offer in terms of C3.13 (b)

### Step 2 - Price and Preference Evaluation

- 1. Review financial offer and correct discrepancies between totals and calculations / summations in accordance with the Tender Data (C.3.9)
- 2. Reduce all tender offers to a common base i.e. comparative offer
- 3. Confirm the tenderers are eligible for the preferences claimed
- 4. Score Tender Offer for Preference
- Score Tender Offer for Price
- Total Points and rank Tender Offers.

The Preferential Procurement Policy Framework Act, 2000 will apply and tender evaluation points will be awarded to the tenderers who complete the Preferencing Form 2.1.6 Preference Points Claim Form SBD 6.1, (80/20 version) and who are found to be eligible for the preference claimed.

Preference points shall be scored in accordance with the following provisions: 80/20 preference point system for acquisition of goods or services with a Rand value below R50 000 000 (all applicable taxes included):

### Employment of Local Labour

PSC will be established through the appointed ISD Agent.

A CLO will be appointed also appointed also through the ISD Agent and Ward Councillor.

The successful Tenderer will be required to liaise with the appointed CLO to recruit his workforce and will be required to produce weekly records suitably detailed to enable the Employer's Agent, or his authorised representative, and Local Communities to ascertain that the labour requirements are achieved.

Involvement of Local Supplies and Sub-contrators

Sub-Contracting 30% of Value of Work to EMEs and/or QSEs is not applicable for this contract due to estimated value of the project. However, if the bidder wishes to subcontract a percentage value of work to local EMEs and/or QSEs, the Preferential Procurement Regulations (2017 shall apply.

## Standard Conditions of Tender

This standard is issued in terms of sections 4(f), 5(3)(c) and 5(4)(b) of the Construction Industry Development Board Act 38 of 2000 read with Regulation 24 of the Construction Industry Development Regulations, (as amended) issued in terms of section 33.

#### Contract Data

General Conditions which form part of the Conditions of Contract for Plant and Design-Build for Electrical and Mechanical Works and for Building and Engineering Works Designed by the Contractor, First Edition 1999 (Yellow Book) published by the International Federation of Consulting Engineers (FIDIC)

Project Duration is 12months

The Defects Liability Period is 12 (twelve) months, measured from the date of issuance of the Taking-Over Certificate.

Time for access to, and possession of, the Site is 28 Days from the Commencement Date

Amount of Performance Security is 10 % of the Accepted Contract Amount

Delay damages for the Works is R2500,00 per day, for each day Time for Completion is not achieved.

Maximum amount of Delay damages is 10% of final Contract Price

Percentage of retention - 10% reducing to 5% upon the issue of a Taking-Over Certificate

Submission of Contractual Documentation after appointment is 14 Days.

Payments - The amount certified in the Interim or Final Payment Certificates within 56 days after receipt by the Employer of the payment certificate signed by the Employer's Agent.

### 4.3 OHS Requirements

The bidders are required to provide a suitably qualified OHS Officer.

The successful bidder will be required to submit a Health and Safety File for approval by the Agent.

### 4.4 Environmental Requirements

Bidders to refer to attached Environmental Specifications attached (CD) to the document.
