BID SPECIFICATION

Amatola Water invites quotations from suitably qualified and experienced service providers for the **Supply and Install Ultra Pure Water System**

1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

2. SCOPE OF WORK

Laboratory Specification for Ultrapure Water System (Milli Q Water/)

- Water Purification system capable of independently dispensing both Type I and Type II water.
- Type II able to use tap water as feed (able to accept up to 2000 micro Siemens conductivity)
- Tap water should be treated in a pre-treatment cartridge for efficient removal of particles, colloids, free chlorine and hardness
- Should have a polishing cartridge capable to remove different type contaminants before the water is delivered from dispensers.
- All the cartridges used should have considerable life
- Should have intuitive control system to allow access to system information (regular use, maintenance and system management).
- The system to have TOC monitoring for prevention of organic breakthrough.
- Should consist of the sensor to regularly monitor the system operation to ensure it operate within specifications.
- Should consist of data tracking system to provide data management and long term electronic archiving for the system information.
- The cartridges should be easily replaceable at low cost
- The Equipment should have a low maintenance cost
- The generated water should be treated with UV to destroy bacteria, before it is stored in the storage tank
- Should have Ethernet connection which will allow the user to transfer data to LIMS or personal computer.
- Should be supplied with 60L storage tank capable of maintaining the purity of stored water
- A vent filter should be there for preventing airborne contamination.
- Biofilm formation should be prevented

- It must be able to produce ultrapure water of not less than 240L/day
- Should be able to produce water suitable for trace element analysis, up-to ppt levels.
- The water dispensers should be designed such that various small filters/cartridges can be connected for obtaining specific quality water for different research needs (Ultra-pure water free of particulates, pyrogens, nucleases, VOCs, endocrine disruptors and organics for LC.
- Should be able to dispense pre assigned volume of water
- Should have electrodeionisation or other equivalent or superior technology for removal of ions
- The resin beads used should be of superior quality and should not degrade by exposure to harsh chemicals
- The Resin beads should be able to be continuously regenerated without affecting its quality
- The module should be able to continuously regenerate its beads used. Thereby effectively reducing operational cost
- Independent Dispensing Unit: Attached suitable filter at Point of delivery unit to remove particulate materials and microorganisms (0.22 μm pore size filters), Option of connecting 2 units with the main water producing unit. Adjustable, rotating unit with multi-colour display screen indicating TOC, Resistivity, flow rate, water level, alarm etc. to be directly accessible from the point of delivery unit
- Production rate minimum 5L/h
- Should have calibrated meters for continuous monitoring and display of water quality parameter
- The system software must comply to design specifications with full system control.
- Ability to keep/store records of all daily water purification system events (up-to a year)
- Should have customizable alert and alarms.
- Should have certificate of calibration from recognized international agencies
- Should have certificate of conformity from recognized international agencies
- Should meet internationally recognized safety norms (declaration of conformity, certificate of quality and the application pack)
- Prompt services should be available
- A minimum warranty for one year.
- Maintenance: To avoid maintenance errors and to improve traceability, the internal primary consumable water purification cartridges will have a built-in RFID tag
To comply with Standard requirements, the resistivity meter should be able to display the non- temperature-compensated resistivity.
