8. JOINT VENTURE REQUIREMENTS

DEFINITION:- “Joint Venture or Consortium”: means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.

BID SPECIFICATION

1. SCOPE OF WORK

1. The preferred service provider(s) must be prepared to cater for all dietary preferences including but not limited to religions, culture, vegetarian, kosher and halaal.(Caterer to provide proof)
2. The quality of food prepared must adhere to acceptable food industry standards and must be prepared in a clean and hygienic manner in accordance with all health and safety regulations.
3. The preferred service provider(s) must provide adequate and sufficient catering equipment, cutlery (Knives, Forks, table Spoons) and crockery when required.
4. Service providers must adhere to timeframes and the delivery of services must be within 24 hours of placing the order.

DÉCOR

1. To arrange décor on tables including table cloths.
2. Food warmers and all appliances necessary for catering.
3. Waiter and waitresses to be dressed appropriately when serving (if applicable).

CRITICAL DELIVERABLES

1. Delivery of equipment and setting up of food must be completed at least 45 minutes before food is served.
2. The service provider may not provide a duplicate lunch buffet when booked for consecutive days.

SKILLS, KNOWLEDGE AND QUALIFICATION

APPOINTMENT, COMMENCEMENT AND DURATION

Due to the expected high volume of bidders and the minimal catering opportunities, a **panel** of bidders will be selected based the expertise and experience presented in their bid document. The successful bidders will be rotated as per their 80/20 results. Bidders who have grossly under-priced rates will not be considered.

The service provider(s) will be appointed for the duration of this contract for 36 months on a rotational basis.

QUALITY ASSURANCE REVIEWS OF THE WORK

The successful bidder shall ensure that all work conforms to hygiene and quality as per the agreement to be signed. Amatola Water may inspect the premises of the caterer where food is being prepared to ensure food is prepared in a hygienic environment.

GENERAL REQUIREMENTS

1. Bidders must provide all the information requested in the Terms of Reference and Instruction to Bidders.

DELIVERY

Delivery of equipment and setting up of food must be completed at least 45 minutes before food is served.

The service provider may not provide a duplicate lunch buffet when booked for consecutive days.
