1. BID SUBMISSION:

- 1.3. 2. BID PUBLICATION

RFQ document will be available from **Friday**, **07**th **August 2020** at Amatola Water website at www.amatolawater.co.za.

3. BID SUBMISSION

The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the Bid/Tender Box, located in the reception area of Amatola House, 6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

4. DISQUALIFYING FACTORS

All Bids must remain valid for a period of 90 (Ninety) days from the closing date as stipulated in the Bid document.

6. <u>AUTHORITY TO SIGN BID DOCUMENTS</u>

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

Form A must be completed. Failure to complete Form A will invalidate your bid.

7. JOINT VENTURE REQUIREMENTS

<u>DEFINITION</u>:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.
- e. A trust, consortium or joint venture will qualify for points of their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- f. 8. CONDITIONS OF TENDER

- III. Amatola Water reserves the right not to accept any proposal and cancel the bid as and when the need arises.
- IV. The contractor must provide references on Form B that the company has undertaken at least 3 projects of a similar nature. Failure to provide proof will invalidate your bid.
- V. Failure to comply with the above requirements will result in submitted proposals being disqualified.

BID SPECIFICATION

Amatola Water invites quotations from suitably experienced suppliers to provide the goods for the Hiring of an Excavator and Lowbed with Driver Operator and a Ten Cube Tipper Truck for five days as set out below:

SCOPE OF WORK

A. 5 Days contract to hire an Excavator with Driver Operator and Lowbed (2 days delivery of the machine and collection of the machinery) and Ten Cube Tipper Truck also with Driver Operator for Five Days

Evaluation Criteria

- Proof of ownership will be a requirement.
- Provision of previous experience as an Excavator supplier (at least 3 references)
- Delivery Period of not more than 1 day after the receiving the order.

Scope of work:

- 1. The Excavator must be quoted on daily wet rate and have its own operator.
- 2. Operator must produce the following:
 - a. Proof of competence that the operator can operate the machine.
 - b. Medical certificate of fitness.
- 3. Rain delayed days will not be billed but recorded as non-productive hours/days.
- 4. Transport of the Excavator to and from the project area will be rated separately.
- 5. Accommodation and food, if applicable, for Plant operator must be arranged by Plant Hire Company and must be included in the daily rate quoted.
- 6. Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.
- 7. Any downtime of the Excavator machine due to own problems e.g. diesel shortage, operator not available on site, breakages etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- 8. Excavator must be available on site by the successful company outside of agreed working hours when requested by Amatola Water supervisor.
- **9.** The excavator will be required to work on site as and when needed and Amatola Water reserves a right to terminate or discontinue with services rendered due to work being completed and or non-performance by the service provider.

- The driver -operator of the machine shall comply with the Health and Safety regulation.
- The service provider will submit a summary of the hours after the machine has been used, or after the job has been completed if it's a short period, which will be certified for payment by the foreman or responsible person and Manager according to the weekly records.
- Amatola Water reserves the right to increase or decrease the contract period or number of Excavator required or any part thereof if project work on the contract is cancelled or work has come to an end. This will be communicated to the contractor in advance when and for how long the contract will be stopped/cancelled/ceases.

Pricing Guidelines

- Prices must be per item description in the pricing schedule below.
- Only firm prices will be accepted, Non- Firm prices (including prices subject to rates of exchange will not be accepted.

Pricing on downtime approval

- Any downtime caused by Amatola Water on TLB not working will be calculated and paid at 50% less to normal daily rate, and any other downtime of the Plant, TLB due to supplier problems e.g. operator not available on site, breakages etc. will be deducted from the normal hours worked and must be shown on the daily logbook for reconciliation purposes. Note: arranged cancelation between Amatola Water and supplier communicated before 12 hrs due to unforeseen circumstances & natural courses, example (rainy days) won't be classified as downtime, but as time lost and won't be paid.


