

1.3. ## 3. BID SUBMISSION

The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the Bid/Tender Box, located in the reception area of Amatola House, 6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

## 4. DISQUALIFYING FACTORS

(a) The following forms must be completed in full as per the requirement of the bid.

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

Form A must be completed. Failure to complete Form A must invalidate your bid.

## 7. JOINT VENTURE REQUIREMENTS

**DEFINITION:**- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.
- e. A trust, consortium or joint venture will qualify for points of their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- f. #### 8. CONDITIONS OF TENDER

- III. Amatola Water reserves the right not to accept any proposal and cancel the bid as and when the need arises.
- IV. The contractor must provide references on Form B that the company has undertaken at least 3 projects of a similar nature. Failure to provide proof will invalidate your bid.
- V. Failure to comply with the above requirements will result in submitted proposals being disqualified.

## Additional Bid/RFQ Condition

Bid/ RFQ documents must be submitted intact and no portion of the document may be detached, loose submissions will be rejected, and the bidder will be disqualified.

#### **BID SPECIFICATION**

The objective of the tender process is to appoint service providers to submit proposals for the Provision of TLB and Rollback services to work in Butterworth pipeline, valve repairs and manhole construction.

<u>Note</u>: The work will be a start & stop kind of work, refurbishment of a live bulk pipeline, and the permission to work will be requested and agreed to between ADM & AW responsible persons. During this period the TLB will be requested to go of site and be re- requested according to the agreed schedule of work. Only the TLB transport trips will be paid as per request to live site or come back to site.

#### The following is covered in the scope of work:

- The Plant machinery must be quoted on an Hourly wet rate and have its own operator.
- TLB to be able to travel between sites on its own within the Butterworth Bulk Water Network.
- The Rollback to be quoted on return trip amount.
- The minimum normal hours per day shall be charged at eight hours (8 hours) per full day. Any time over the normal time will be charged as overtime but the rate quoted won't change.
- The operator must be competent to excavate a trench within or between surrounding existing services and according to levels provided by the foreman or responsible person.
- The owner of the machine shall submit proof of ownership as a requirement when submitting his guote.
- The owner of the machine shall submit the daily working hours of the machine every Monday of the week which hours will be compared with the records of the Amatola Water foreman or responsible person.
- The operator of the machine shall comply with the Health and Safety regulations of the Occupational Health and Safety act.
- TLB must be in a good road worthy condition
- The service provider will submit a summary of the hours after the machine has been used which will be certified for payment by the foreman or responsible person and Manager according to the weekly records.
- The fueled (Back Actor)TLB with competent operator who can excavate at prescribed slopes with the use of profiles shall be used to excavate trenches, 1.5m to 2m deep for the laying of pipelines up to 750mm and will be used for any other general purposed were Back Actor can be used.
- The bucket width shall be between 450mm and 600mm for TLB.
- Accommodation, food, PPE and workman's compensation for the TLB Operator must be arranged by Supplier and be included in the daily rate quoted.
- Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.

- Any downtime of the Plant TLB due to own problems e.g. operator not available on site, breakages etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- Any breakages or replacement on the machine must be responded to within 24 hrs.
- Plant machinery must be available on site when requested by the successful supplier outside of agreed work hours.
- Amatola Water reserves the right to increase or decrease the contract period or number of TLB's
  required or any part thereof if project work on the contract is cancelled or work has come to an
  end. This will be communicated to the contractor in advance when and for how long the contract
  will be stopped/cancelled/ceases.

- Only firm prices will be accepted, Non- Firm prices (including prices subject to rates of exchanged variations) will not be considered.


