3. BID SUBMISSION

The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the Bid/Tender Box located in the reception area of Amatola House, No.6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

7. JOINT VENTURE REQUIREMENTS

<u>DEFINITION</u>:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.

BID SPECIFICATION

The objective of the tender process is to appoint service providers to submit proposals for the Provision of Excavator and Rollback services to work in Albany Coast.

<u>Note</u>: The work will be a **start & stop kind of work**, and the permission to work will be requested and agreed to between Albany Coast RO Plant & AW responsible persons. This is a rate based RFQ Capped at R500 000.00 Incl.Vat. where the Excavator will be requested to go of site and be re- requested according to the agreed schedule of work.

The following is covered in the scope of work:

- The Plant machinery must be quoted on an Hourly wet rate and have its own operator.
- The Rollback to be quoted on return trip amount.
- The minimum normal hours per day shall be charged at eight hours (8 hrs) per full day. Any time over the normal time will be charged as overtime but the rate quoted won't change.
- The operator must be competent to excavate a trench within or between surrounding existing services and according to levels provided by the foreman or responsible person.
- The owner of the machine shall submit proof of ownership as a requirement when submitting his quote.
- The owner of the machine shall submit the daily working hours of the machine every Monday of the week which hours will be compared with the records of the Amatola Water foreman or responsible person.
- The operator of the machine shall comply with the Health and Safety regulations of the Occupational Health and Safety act.
- The Excavator must be in a good road worthy condition
- The service provider will submit a summary of the hours after the machine has been used which will be certified for payment by the foreman or responsible person and Manager according to the weekly records.
- The fueled Excavator with competent operator who can excavate at prescribed slopes with the use of profiles shall be used to excavate trenches.
- Accommodation, food, PPE and workman's compensation for the Excavator Operator must be arranged by Supplier and be included in the daily rate quoted.
- Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.
- Any downtime of the Excavator due to own problems e.g. operator not available on site, breakages etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- Any breakages or replacement on the machine must be responded to within 24 hrs.
- Plant machinery must be available on site when requested by the successful supplier outside of agreed work hours.


