The sealed envelope must be deposited in the Bid/Tender Box located in the reception area of Amatola House, No.6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- b. Each member of the joint venture/consortium's taxes must be in order.

Amatola Water invites quotations from suitably qualified and experienced service providers for the **Hiring of Honey Sucker with Jet Pump to Empty Septic Tanks**

BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

Scope of Work

- 1. The Honey Sucker and Jet pump must be quoted on an hourly rate and have its own operator.
- 2. Operator must produce the following:
 - a. Proof of competence in writing he can operate the machine.
 - b. Medical certificate of fitness.
- 3. Rain delayed days will not be billed but recorded as non-productive hours/days.
- 4. Security and liabilities of the Plant machinery is the responsibility of the Plant Company and Amatola Water won't be held responsible for any losses or damages to the machine.
- 5. Any downtime of the Honey Sucker due to own problems e.g. diesel shortage, operator not available on site, breakages etc. will be deducted from the actual hours worked and must be shown on the daily logbook for reconciliation purposes.
- 6. The Honey Sucker will be required to work on site as and when needed and Amatola Water reserves a right to terminate or discontinue with services rendered due to work being completed and or non-performance by the service provider.
