- 1.3. BIDDERS MUST REGISTER ON THE CENTRAL SUPPLIER DATABASE (CSD) TO UPLOAD MANDATORY INFORMATION NAMELY: (BUSINESS REGISTRATION/ DIRECTORSHIP/ MEMBERSHIP/IDENTITY NUMBERS; TAX COMPLIANCE STATUS; AND BANKING INFORMATION FOR VERIFICATION PURPOSES). ### 1. **DEFINITIONS**

The word "Bidder/Tenderer" in these conditions shall mean and include any firm of Contractors, Suppliers, Service Providers or any company or body incorporated or unincorporated.

### 2. BID PUBLICATION

BID document will be available from **Monday**, **19 September 2022** at Amatola Water website at <a href="https://www.amatolawater.co.za">www.amatolawater.co.za</a>.

### 3. BID SUBMISSION

The original completed bid documents must be submitted in a sealed envelope endorsed with the Bid Number and Bid Description as detailed in the Tender Data. The sealed envelope must be deposited in the Bid/Tender Box, located in the reception area of Amatola House, 6 Lancaster Road, Vincent, East London, not later than the time and date specified on the cover page and SBD 1 of this bid.

### 4. BID Evaluation Criteria

BID will be evaluated on the below factors:

- I. Stage 1 Compliance Mandatory fields completed, these include:
  - a. BID document completed in non-erasable ink, no tippex or correctional fluid used
  - b. BID document submitted in full no missing pages

### 6. PERIOD OF VALIDITY FOR BIDS AND WITHDRAWAL OF BID AFTER CLOSING DATE

All Bids must remain valid for a period of 90 (ninety) days from the closing date as stipulated in the Bid document.

### 7. AUTHORITY TO SIGN BID DOCUMENTS

In the case of a Bid being submitted on behalf of a company, close corporation or partnership, evidence must be submitted to the Amatola Water at the time of submission of the Bid that the Bid has been signed by persons properly authorised thereto by resolution of the directors or under the articles of the entity.

Form A must be completed. Failure to complete Form A will invalidate your bid.

### 8. JOINT VENTURE REQUIREMENTS

<u>DEFINITION</u>:- "Joint Venture or Consortium": means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter into a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.
- c. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide a combined joint venture/consortium Tax Clearance Certificate.
- d. After the award of a contract to a joint venture/consortium, the successful joint venture group or consortium must provide the details of the joint venture / consortium banking details.
- e. A trust, consortium or joint venture will qualify for points of their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- f. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

### THE JOINT VENTURE/CONSORTIUM AGREEMENT MUST CONTAIN THE FOLLOWING: -

- b. Who the signatory of authority will be.
- c. How the joint venture/consortium share of profit will be split.
- d. The bank account details where payments will be deposited into.
- e. The agreement must be signed by all parties.
- f. The agreement must be certified by a Commissioner of Oaths.
- g. The postal and physical address where all correspondence will be sent to

### 9. CONDITIONS OF TENDER

- I. Submission of this proposal signifies the applicant's acceptance of the conditions as laid down in this document, unless clearly stated otherwise.
- II. Any expense incurred by the applicant in preparing and submitting this proposal will be for the applicant's account.
- III. Amatola Water reserves the right not to accept any proposal and cancel the bid as and when the need arises.
- IV. The contractor must provide references on Form B that the company has undertaken at least 1 projects of a similar nature.
- V. Failure to comply with the above requirements will result in submitted proposals being disqualified.

### **10. SPECIAL CONDITIONS**

- 1. **PRICE NEGOTIATION**: Rate per Load will be negotiated to an average rate that will be inline with market related prices and similar negotiations will be applied to the rate per kilometre. All responsive bidders will be requested to accept the negotiated market related rate prior to award.
- 2. **ROTATION OF WORK**: Responsive and qualified bidders will be listed in ascending order per LM into a rotation and be appointed as and when required.
- 3. **DELIVERY TURNAROUND TIME**: Due to the urgency of the required services, if the bidder fails to deliver within 48 hours the purchase order will be cancelled.

### **BID SPECIFICATION**

Amatola Water invites quotations from suitably qualified and experienced service providers for the PANEL FOR PROVISION OF WATER TRUCKS (WATER CARTING) TO SUPPLY WATER IN VARIOUS MUNICIPALITIES WITHIN THE PROVINCE OF EASTERN CAPE ON ADHOC BASIS FOR THE PERIOD OF THREE YEARS.

### 1. BACKGROUND

Amatola Water is an Eastern Cape based state-owned water services utility (water board), established in 1997, in terms of the Water Services Act. Its prime function is to provide bulk water and sanitation services to water sector institutions, water service authorities and other customers as provided for in the South African water services legislation. Amatola Water's service area includes Buffalo City, the Amathole District and portions of adjoining districts in the central Eastern Cape.

### 2. SCOPE OF WORK

### 2.1 Scope of work

The Scope of work for this project is summarised as follows:

- Provision of portable water to the communities, schools, Municipalities and other government institutions through water trucks within the Eastern Cape Province;
  - The Service Provider to cart portable water on as and when basis as instructed by an Official that will be confirmed by Amatola Water;
  - Logsheet to be filled properly by Service Provider, signed and stamped by an
     Official after each and every load, see the attached logsheet on Appendix A;
  - o The Service Provider to submit weekly Progress Report to Amatola Water;
  - The Service Provider to cart portable water only from registered water source confirmed by an Official;
  - The Service Provider to ensured that the water truck, associated pipework and equipment is disinfected and suitable to transport portable water prior use;
  - The total number of loads to be delivered will be limited based on the amount of the Purchase Order issued by Amatola Water to the Service Provider. It is the responsibility of the Service Provider to ensure that the total number of loads delivered with inclusive of the kilometers travelled do not exceed the value of the Purchase Order

### 2.2 Specification

Required specifications and requirements for this project are as detailed below:

- The capacity of water truck to be a minimum of 10 tonnage and to be able to deliver a single load of 10 000 liters of portable water. The Service Provider to provide the proof of water truck registration papers.
- The service provider to ensure his/her water truck is roadworthy before carting water;
- The Service Provider to ensure the water truck is marked clearly with the company name and nature of business;
- The Service Provider to ensure that the water truck comply with any local regulations and standards set by South African authorities:

 The Service Provider of the water truck that used to transport drinking water must ensure that tank/s, associated pipework and equipment used for loading or unloading of portable water have not been used previously for transporting any noxious, toxic or hazardous matter, non-food liquids or human or animal wastes.

#### Note:

#### PROOF OF BUSINESS ADDRESS

Lease Agreement / Municipal Bill or Letter of Residence from Ward Councilor. Should the bidder be operating in more than one municipality, proof of business address is required for each office.

### • PROOF OF WATER TRUCK OWNERSHIP

REGISTERED UNDER THE BIDDING COMPANY or PROOF OF LEASING - Leasing Agreement.

### REIMBURSEMENT FOR KILOMETERS

The service provider will only be **reimbursed for water carted** from water source to a delivery point only. The kilometers from home/business premises to water source will not be reimbursed.

• Successful EMEs and QSEs will be required to enter into a memorandum of agreement with Amatola Water enterprise development program.

#### 11. EVALUATION PROCESS

Bidders must submit all required documents indicated hereunder with the bid documents at the closing, date and time of the bid. During this evaluation phase, bidder's responses will be evaluated based on the documents submitted under mandatory requirements. **Any bid that does not meet these requirements will be disqualified, and will be considered as non-responsive**The received bid proposals will be evaluated in three stages to arrive to the final phase of bid award, and the phases will be as follows:

### STAGE 1 - COMPLIANCE SCREENING / ADMINSTRATIVE COMPLIANCE

In this phase all bids received will be verified for compliance and completeness of the submitted proposal per the below set of requirements. Bidders who fail to comply with the below requirements will be eliminated and bidders who comply with the below progresses to the next phase.
