5. JOINT VENTURE REQUIREMENTS

DEFINITION:- “Joint Venture or Consortium”: means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter a joint venture / consortium agreement the following minimum requirements must be met: -

TERMS OF REFERENCE FOR THE PROCUREMENT OF SERVICES FOR A GRAP COMPLIANT ASSET REGISTER

1. BACKGROUND AND INTRODUCTION

Amatola Water (AW) is an essential services utility operating in the water sector in the Eastern Cape. AW was established in 2007, in terms of the Water Services Act (Act 108 of 1997) and is accountable to the Minister of Water and Sanitation as its executive authority. The current area of operation covers a tract of central Eastern Cape Province, encompassing most of the Amathole and Chris Hani District Municipalities together with lesser portions of Joe Gqabi and Sarah Baartman Districts. AW has water treatment works and offices in East London (Vincent and Nahoon Dam), Peddie and Bushman's River area, Keiskammahoek area (Sandile), King Williams Town Area (Laing).

The purpose of this document is to invite potential service providers for proposals for doing annual update of a GRAP compliant asset register including processes and procedures with specific focus on immovable assets and work in progress.

The proposals must include details on the skills transfer process of the entity's officials to manage the asset management processes and procedures and maintain the asset register on a sustainable basis with minimal external assistance.

2. SCOPE AND DELIVERABLES

- a) The appointed service provider will be responsible for Project Oversight and Reporting:
- Attending project steering committee meetings
 - Submitting monthly progress reports.
- b) Implementation of a GRAP-Compliant Asset Register:
- Conducting physical verification of immovable assets.
 - Providing verification software for movable and immovable assets.
 - Asset unbundling according to a defined hierarchy.
 - Providing audit support.
 - Reviewing and revision of useful lives and residual values of immovable and movable assets for compliance with GRAP.
 - Conducting impairment assessment for immovable and movable assets based on verification results in compliance with GRAP.
 - Assisting the entity in successfully addressing the audit findings on PPE as per the Auditor-General's report.
 - Reconciling between the asset register and the General Ledger/ Trial Balance.
 - Reporting on work done including detail on applied methodologies.
 - Training of and transfer of skills to identified staff.
- c) GRAP compliance requirements:
- Detail asset description.
 - Detailed location description.
 - Bar code, unique identifier, serial number (for electronic assets and where applicable), erf number (for land and buildings and where applicable) (or other number to distinguish it from other assets).
 - Purchase price.
 - Acquisition date.
 - Estimated useful life (original and revised).
 - Estimated residual value.
 - Remaining useful life.
 - Depreciation
 - Accumulated depreciation
 - Disposal — date, proceeds, depreciation up to date of disposal.
 - Information on a change in accounting estimate as a result of change in useful life or residual value — date reassessed, etc.
 - Impairment loss recognised or reversed.

- Carrying amount at the beginning and end of the reporting period.
- Locations for assets including GPS co-ordinates.
- Addresses as well as deeds information for land, buildings and other property under the control of Amatola Water.
- Condition of the asset to assist in determining the remaining useful life of an asset and whether it may possibly be impaired.
- Person responsible for safeguarding and maintaining the asset(s).

d) Additional Requirements:

- Project management skills required to achieve change, and skills transfer to a diverse group of officials, partners and other stakeholders.
- Ensure compliance with all applicable GRAP accounting standards and guidelines/instructions issued by relevant authoritative bodies/institutions.
- Illustrate proof of previous experience and proof of similar work successfully concluded.
- Extensive knowledge of Legislation and Regulations relevant to the project.

3.3. PROOF OF REGISTRATION REQUIRED

Service providers must provide:

- Proof of registration with the Engineering Council of South Africa (ECSA) as Professional Engineer or Professional Technologist in the Civil Engineering discipline.
- Proof of registration with the South African Institute of Chartered Accountant (SAI CA) as a CA(SA).
- Proof of Level of expertise and qualifications of personnel.

4. REPORTING LINES

The service provider will report directly to the Asset Accountant of Amatola Water. The service provider will work closely with the Assets section and the Finance department.

5. ORGANISATIONAL SETTING

During the contract period, the service provider will work on site and when needed. AW will provide office space as needed for the service provider. The Consultant will receive the necessary support and data from the assets section of AW

6. DURATION OF ASSIGNMENT

The Consultant is expected to provide professional services over the period April 2025 - October 2025.
