6. JOINT VENTURE REQUIREMENTS

DEFINITION:- “Joint Venture or Consortium”: means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

Should a group of companies/firms and/or interested parties wish to enter a joint venture / consortium agreement the following minimum requirements must be met: -

- a. A properly signed copy of the joint venture/consortium agreement must be attached.
- b. Each member of the joint venture/consortium's taxes must be in order.

TERMS OF REFERENCE FOR THE PROCUREMENT OF ACCOUNTING SERVICES

1. BACKGROUND AND INTRODUCTION

Amatola Water (AW) is an essential services utility operating in the water sector in the Eastern Cape. AW was established in 2007, in terms of the Water Services Act (Act 108 of 1997) and is accountable to the Minister of Water and Sanitation as its executive authority. The purpose of this document is to invite potential service providers to submit proposals for accounting services related to proper and complete implementation of GRAP 11, 104,109 and other relevant GRAP standards, ensuring their accurate and consistent application.

2. SCOPE AND DELIVERABLES

The Service Provider will be responsible for performing the following services:

- Ensure accurate and consistent application of GRAP 11, GRAP 104, GRAP 109 and other relevant GRAP standards.
- Assist with the effective application of GRAP 104 amendments.
- Cover all aspects of accounting, including revenue recognition, cost measurement, and disclosures.
- Review and develop accounting policies

3. REQUIRED EXPERTISE

Company Experience : The company must provide full details of their similar successfully completed projects related to the accounting services. The company should provide a proof of atleast 3 completed projects. The company is expected to atleast have 1 resource dedicated to the entity until the submission of the Annual Financial Statements

Qualifications : The project leader must be a Chartered accountant registered with South African Institute of Chartered Accountants (SAICA) with minimum of 6 years' experience in

accounting services. Other support team members in the project are also expected to be registered Chartered Accountants with at least 3 years' experience in Accounting Services.

Methodology: The service provider is expected to clearly outline how the project will be delivered within the expected timelines developing a clear project plan

4. DURATION AND EXPECTED DELIVERABLES OF THE ASSIGNMENT

The Consultant is expected to provide the following deliverables on or before 12 August 2025

- Methodology paper
- Prior and current year journal entries
- Updated Accounting policy and disclosure notes

The consultant will also be expected to provide audit support after submission of the Annual Financial Statement over the period September 2025 – 30 October 2025.
